#### TV Violence and PTSD

When PTSD symptoms got worse for some veterans, it may have been related to how closely what they were seeing on the news reflected what they had gone through while serving. To help counter reactions:

Consider limiting your exposure to news on television. While media coverage may draw you in, increased viewing can raise stress levels. Watch yourself for signs of anger, rage, depression, worry, or other negative feelings. Take a time out from the news to let yourself recover from these feelings.

Keep up with daily schedules and routines. Try to include more pleasant activities in your day, even for brief periods of time.



# The Chaplain's Corner -





As I write this, I am also preparing for Holy Week, the week before Easter Day.

One of the most meaningful things that takes place at our church during the week occurs on Thursday evening. In addition of focusing on Jesus' call to the sharing of His body and blood at the Holy Eucharist or Holy Communion, is his call to wash one another's feet. Each year, I remind people ahead of time that we are going to do this. Of course, involvement is voluntary. This for one gives

people time to wash their feet ahead of time if they are going be involved. This is not for my sake as I am the one generally washing feet. We all seem to be reticent to have someone else wash our feet. To be honest most of us do not even want a stranger touching our feet.

So if it so distasteful, why does Jesus call for us to do it? I do not know, if you have washed a strangers feet or had them wash yours but it is about the most humbling experience you can think of for both the washer and the washee. When I say humbling yourself, I need to say something about what that means. Often when we think about being humble, we think that means to denigrate or demean ourselves. To humble oneself, simply means to accept who

you are. Not trying to be anything more or less. The bottom line is that Jesus is calling us to be a servant to all.

When I think of servant hood and what that means, I think of the members of the ADBC. They gave of their lives not only for you and me but for people they did not know or would ever know. In fact, they did it for people who if they had known them they would have likely disliked them. I doubt if any of them stopped to think of it this way. servant hood. I am sure if you asked them about the servant part of that they would look at you rather puzzled as they had never thought of it that way.

So I would ask that each of you take a few moments as you prepare to celebrate Easter and think about how you can live into the call to being a servant to all. If you have the opportunity, to participate in foot washing at your church I would recommend you at least consider being involved.

#### Dear Editor,

Eleven years ago I met a man I met on Bataan who was looking for information on an uncle (I believe) named Maj. Irving R Mendelson, who was wounded in 1 Corps on 23 Jan. 1942. He had no further information. I checked the roster of US military personnel in the Philippines on 7 December 1941 and did not find the name. Two weeks ago at the National Archives I found a brief reference to a Capt. Mendelson (different spelling) with the 1st Battalion, 1st Philippine Division, with the South Luzon. It was in a larger document in Record Group 407, Philippine Archives Collection, Stack 270/ Row 49/Compartment 23/Shelf 6/Box 1663, microfilm roll 88. The microfilm has aged badly and I found nothing else.

Then I tried the 11 year old e-mail addresses that my fellow researchers had given me. They bounced back, of way. If any one has any information could you please let me know.



# One Brother Joins the Navy to Serve with his Older Brother--Both are Taken Prisoner of War, One after Surviving USS Houston Sinking, One on Corregidor



Bill Ingram at the tender age of 17 joined the Navy for one reason—to join his brother Robert on the *USS Houston*. He requested duty on the *USS Houston* upon enlistment in June, 1941. On December of 1941, he was on the *Chaumont* an old troop transport, and he was to catch the *Houston* in the Philippines. But the Houston had departed from Manila and set out towards Iloilo, 238 miles south of Manila, to get out of harms way. Bill was four days out at five knots an hour on the *Chaumont* when the Japanese bombed Pearl Harbor. He said, "We were hardly out of sight, but they didn't catch us."

Next he boarded the *Pensacola*, a heavy cruiser. He sailed on that ship until he reached port in Darwin, Australia. If he had stayed on the *Pensacola*, he says, 'I might have missed a lot of excitement. "First, he almost missed getting on the *USS Houston*, but managed to find the ship and he was assigned to the 1st division and told to man the front turret, partly because he could

fit in the small hatch. "I was 17 and weighed a little over 100 lbs."

Once on board he found his brother, Robert, had recently departed from the *USS Houston* and been taken to Corregidor, eventually to be captured as a prisoner of war and sent to Japan. Robert "Inky" had been a signalman on the ship. Once in Corregidor, he joined the Admiral's flag division.

The USS Houston was attacked

on Feb. 4 with a shower from Japanese bombers. The crews on the Houston's guns fired their 5 and 8 inch guns only to find that three-fourths of their rounds didn't explode. Like much of the equipment in the early days of the Pacific War, the guns had not been tested with live ammunition in drills.

The captain of the Houston, Captain Rooks tried to help the light cruiser *Marblehead* which was being showered with bombs. The captain turned towards the *Marblehead* so that his gunners could fire at the Japanese planes. One of the Japanese bombs had gone astray, and Rooks looking for the trajectory missed seeing the bomb as it passed out of view. The 500 pound bomb hit Turret #3 setting off fires as it ignited the gunpowder bags.

Forty-six men died from the blast and one of the men aboard stated that war had come to them in a real way.


The *USS Houston* was patched up and ship fitters replaced the gun house roof by putting in a large steel plate and draping canvas over the turret's side making it appear as though the aft turret was ready for combat. They replaced the old projectiles with 500 live rounds from the *Boise*, which had been sidelined. The crew was eager to go back out and Capt. Rooks roused their fighting spirit by saying they could beat the Japanese with the two turrets that were remaining.

On Feb 14, the *USS Houston* went out to escort four troop ships to reinforce troops on Timor, hoping to keep the island in Allied hands. Around noon, the bugler sounded the call for the men to take positions for air defense as a Japanese Mavis came into view. The gunners sent shells towards the Mavis. A P-40 chased the Mavis. Nine more Mavises and 36 Mitsubishi Type 97 bombers formed to attack the Houston. Capt. Rooks circled his charges and the smoke from the boats guns created a smoke screen. The new ammunition made a difference and the bombers retreated. Seven Japanese bombers took a hit. The crewmen celebrated their victory but were disheartened as Timor had fallen.

It wasn't long before the *USS Houston* would face the Japanese again, this time in a battle that would cause severe losses. A fleet of ABDA ships gathered to search for Japanese forces headed for eastern Java. On Feb. 27th they met up with the Japanese and the first major surface battle of the Pacific War, the Battle of the Java Sea, ensued. After 8 hours, two Dutch cruisers were sunk as well as three

destroyers. The Japanese hit the Houston twice with 8 inch shells, but the *USS Houston* and the Australian ship "*HMS Perth*" had survived. The next day, the 28th, the two ships partially refueled at Batavia before attempting to pass the Sunda Straits and head towards safety in the Indian Ocean and towards Australia.

They met the Japanese invasion fleet made up almost a dozen destroyers, three cruisers, many torpedo boats and minesweepers. *HMS Perth* went down after being hit with four torpedoes, and after midnight, the Japanese targeted the Houston with a torpedo. Then a shell from the Japanese destroyed the number 2 turret and Capt. Rooks told the men to abandon ship. Capt. Rooks died when a shell hit a gun mount and the shrapnel hit him as he came down a ladder from the signal bridge. The order to abandon was remanded and the men from the Houston fought on, hitting three destroyers and a minesweeper.

But then the *Houston* was torpedoed and started sinking. The crew swam away. Red Clymer got a life ring for Bill who was now grateful he had taken swimming lessons at the YMCA. He was told to swim fast and as he looked back he could still see the ship and it was in flames. He said, "I was in the water from 2 in the morning until about 3 PM. Being in the dark was frightening because I didn't know what I would bump into--a dead sailor, a dead Japanese or a dangerous fish." He was picked up by the Japanese and they interviewed him, and clobbered him when they didn't like his answers.

Finally they threw him overboard. He swam to get a life ring, and was eventually picked up by a fishing boat whose owner was letting people on the boat in exchange for gifts. Ingram said, "All I had on was a pair of navy shorts, white shorts, and a white belt and my knife...I gave him my jackknife to get on board."

The currents in the sea headed the men towards Java. Finally, the men on the boat had enough of the trading system and chucked the native overboard. Once on shore, the men walked into what they thought was a Dutch Red Cross site and instead found it was a front for an old prison and the Japanese took them prisoner.

His first beating took place when he said Roosevelt was the greatest man, and not Tojo. After the Japanese sergeant hit Bill with a rifle Page 8-The Quan

and dug him with hob nailed boots, Bill Ingram said, "You stand there with blood running all over you and everything, and he (Tojo) becomes number one." Subservience became necessary to stay alive.

Bill worked on the Burma Road, an engineering feat that has been compared to building the pyramids because so much work was done by human labor.

By the end of the war, Bill was suffering from malaria and dysentery and in retrospect he felt that a few more weeks in Burma might have cost him his life. He suffered malaria stupor so that his trip home through Calcutta and New York remained oblivious to him.

"I woke from my "stupor" to find myself in a New York bar with some buddies. I had a head of lettuce in front of me and didn't know why I ordered it." He started crying and the bartender asked him why he was so disturbed and he said. "I just want to go home."

#### The People Left at Home

Back at home while Bill and Robert were just beginning their hardships, their parents read the headlines in the local paper, titled "Parents Who Lost One Son In Sea War Notified Second Boy Missing in Action." It wasn't until the captured could send out a postcard home that Bill's parents could know for sure that their boys were still alive. In the article, Mrs. Ingram said, "I still believe they will come back to me," in spite of last official reports had them both missing in action. The Navy sent her three reports about Robert, saying he was missing, then that he was alive and then again that he was missing.

The postcards sent out by the captured prisoners allowed for choices that said that the men were fine and treated well. But the men coming home knew differently. They had not been fine or treated well.

After telling his trials to the bartender in New York, the bartender put Bill on a train to Illinois. Once there, he returned to his childhood home only to find his parents had moved. After several inquiries he made his way to the neighborhood where he was told they lived. Once there, he knocked on doors hoping someone would know of his parents. Finally, he noticed a mailman who told him he was within four doors of his parents house. "My mother almost fainted when she answered the door. She was not expecting me."

It was a relief to be home, and Bill stayed home for a month, healing at Great Lakes Naval Hospital. Bill decided to stay on in the navy. He met his wife Yvette in French Morocco and they had two children. He retired from the Navy as a Chief Boatswain Mate.

Note: After returning a call from Bill Ingram who called the *Quan* to talk to us about his experiences, he told me he was a fascinating guy and good-looking, too and chuckled. But they both ended up being true. More information can be found about the U.S.S. Houston CA-30 Survivors Association at http://www.usshouston.org/ The *USS Houston* was a favorite of Pres. Roosevelt and he often sailed on the ship. See our museum donations for some resources on the Houston and the Burma Thailand railway. Its story has been chronicled in the book <u>Ship of Ghosts</u> by James D. Hornfischer.

The number of men on the Houston was over 1,000 and those who survived were 369. Thirteen remain as of March 12,2013.

On May 27, 2009 the American Defenders of Bataan and Corregidor Inc. provided funds to continue the publication of The Quan for a three year period. By reducing the number of issues, George has extended that initial time frame. However, the costs of printing and postage continue to rise and the Board of the ADBC Memorial Society and George are in agreement that costs must be reduced and an annual subscription fee must be implemented.

These changes will not impact the former POWs who were members of the ADBC nor their widows. They will continue to receive The Quan without any cost. George and the Board have agreed that a subscription fee for hard copies of The Quan will be:

## Auction Items Needed for Education Grant Funds

The grants make it possible for the applicants to do the work. These projects help put the true WWII history in the Pacific and the plight of the POWs back into the classroom.

Two grants were chosen for the award. At the Albuquerque 2012 convention they were presented. Scottie Kersta-Wilson used her grant to write a book for students of all ages (primarily middle-school) about her grandfather Zero Wilson, who boosted spirits of POWs with music and theatre in the POW camps. Georgia and James Owens developed "Bataan in a Box" for high school social studies teachers in NM. It contains curricula and materials and can be adapted for other states.

ADBC Memorial Society raises money for the education grants by holding Silent Auctions held annually during the Quan Party at the convention. This year it is Friday, May 24 at 7 pm in Norfolk, VA at the Sheraton Waterside Hotel. Last year the auction raised \$1,475. This year the goal is to make \$4,000.

#### Sam Antonio



Sam Antonio, 92, of Grants, NM, passed away July 12, 2012. He was born June 23, 1920, to Crecensio and Maria Antonio in Anzac, NM. He served in World War II, belonged to the 200th coast artillery, and sur-

vived the Bataan Death March. He received a Bronze Star and numerous campaign medals. He was known for his sense of humor and his love of fishing. He was also a champion archer. His wife Lucy Antonio preceded him in death, as well as a son Leonard, his parents Crescensio and Maria Antonio, his sister Elizabeth Vallo; brothers, Nick and Jose Antonio, and John Sarracino. He was buried in Grants Memorial Park with full military honors by the VFW

Lodge 3221 and 200 attending his service as a final farewell.

#### Frank DeVivo

Frank H. Devivo, 91, died Dec. 1, 2012 in Council Bluffs, IA. At 16 he signed up for the C.C.C. Program, learning soil conservation, etc. When he was 18, he joined the US Army and was sent to the Philippine Islands for basic training. He was due to come back to the States when on Dec. 7, 1941 the Japanese bombed pearl Harbor. Frank was on the island of Corregidor, where they held out for 6 months without any additional rations or ammunition and finally were forced to surrender to the Japanese, May 8, 1942. For the next three and a half years he suffered starvation, forced labor and brutal beatings. He was also sent on a "Hellship" Voyage to northern Japan to work in the copper smelters. Frank was liberated in Sept. 1945, weighing less than a 100 lbs. Frank is the only member from his group of eight that enlisted in 1940 to survive and come home. All the others died in the prison camp. Frank worked on the Union Pacific Railroad, in the mail and clerical department and then the accounting department retiring in 1981. Before being declared legally blind, Frank was an avid gardener and repair man. He volunteered at the Veterans Hospital in Omaha, NE for 12 years and was a lifetime member of Holy Family Church. Survivors include his wife of 66 years, Doris; daughters Patricia Holder (Jack) and Nanci Schnitker of Council Bluffs, IA: sons Steven DeVivo of Broken Arrow, OK and John DeVivo of Blair, NE, 10 grandchildren and 11 great-grandchildren.--submitted by his wife Doris DeVivo

Floramund Fellmeth Difford "Ann" Floramund "Ann" Fellmeth Difford (LTC Army Nurse Corps) August 7, 1913 - July 31, 2012.

Floramund, a dynamic woman completed a long and eventful journey of almost 99 years on July 31, 2012. She was born on August 7,

1913 in Chicago, IL to Henry and Gertrude Fellmeth, the youngest of 13 children and was destined to do great things in her life. Her road began when she graduated from St. Elizabeth School of Nursing with post graduate studies in surgical nursing from Belleview Hospital in New York. She entered the Army Corps on August 1936 and served until November, 1946. She entered the Army Nurse Corps on August 1936 and served until November 1946. Her first assignment was at Fort Warren, Cheyenne, WY where she met her future husband Wallace E. Difford, Jr. Her overseas assignment was the Philippines, where she was one of 104 nurses stationed in Corregidor and Manila. When the war started she was selected to stay behind in Manila with 200 critically wounded Soldiers. On December 31, 1941 it was decided to try and evacuate on the Red Cross Ship "Mactan" and after a month at sea in hostile territory they arrived in Australia. Until US Nursing personnel arrived she set-up the South Pacific Army Nursing service. At the end of 1944 Floramund headed home and on February 2, 1945 she married Wallace E. Difford Jr. Floramund is a recipient of the Legion of Merit and Bronze Star. Floramund and Wallace had four children and helped countless others during their lifetime. She continued her nursing career and retired from Sacred Heart Medical Center Spokane in 1975. She was an active life member, ADBC, the VFW, Turnwater, WA; the American Legion, Dupont, WA, and St. Margaret's Guild, Sacred Heart Catholic Church, Lacey, WA. She is preceded in death by her husband of 65 years, Lt Col Wallace E Difford Jr. and son Gary Henry Difford. He belonged to the Men's Club, the Usher Board, Board of Trustees, and the Wesleyan Sunday School Class at that church until it closed, and he joined Whitefield United Methodist Church. He is survived by his wife of 66 years, Ludell, his son H. Lewis (Mary) Hazel, daughter Christy (Michael) Plummer. Grandchildren Chris (Gina) Hazel, Chuck (Kellie) Hazel, Benjamin Plummer, Natalie (Jonah) Broulette. His family said, "He loved life and fought death until the Lord said it was time to come home."

#### Dale T. Minger

Dale T. Minger, 92, of Wadena, Iowa died Sunday April 1, 2012. He was born Jan. 15, 1920 to Glen (Erikson) Minger. He attended country school until the eighth grade and graduated from Wadena High School. He then started college at Upper Iowa Univer-

sity in Fayette. He had to postpone his college dream for 50 years due to the war and subsequent Post Traumatic Stress Disorder. He did earn his degree. Dale was a great farmer, and helped his parents with bills when he worked in cleaning an island on the Mississippi. He enlisted in the US Army when World War II broke out. He fought on Corregidor until it was surrendered and he went to Japan as a prisoner of war. When he came home, the Veterans Hospital in Iowa City aided his recovery. He also found solace from working with the farm animals. He married Olive "Ollie" Struss. He attended the Wadena Community Church. Dale Minger was preceded in death by his parents, his wife, Ollie, a brother Bob, his brother-in-law, Bill O'Laughlin Sr. and a nephew, Bill O'Laughlin Jr. He is survived by his sisters Marjorie (Bill) Strudhoff of Hawkeye, Iowa and Arlene O'Laughlin of LaCrosse, Wisconsin; a sister-in-law, Ann Minger; and several nieces, nephews, great nieces, and great nephews.

#### **Glenn Stuart Oliver**

Glenn Stuart Oliver, 93 died, November 25, 2012 with his wife Ester and his family at his side. He was born April 28, 1919 in Brainerd, Minnesota and graduated from Aitken High School in 1937. In 1940, he joined the 34th Tank Company (later renamed Company A) of the Minnesota National Guard. He married Esther three days before reporting for duty. He trained in Radio Electronics Repair School and headed to the Philippines. He was on Clark Field when the Japanese bombed the Philippines after their Pearl Harbor Attack. Shrapnel struck Oliver in the head in an attack in the next month and he received a Purple Heart.

Glenn survived the Bataan Death March and was held in the following camps: Cabanatuan, Nichols Air Field and Bilibid Prison. Glenn was one of nine survivors of the "Hellship," The Arisan Maru. The ship, not marked as having POWs, was attacked by American torpedoes that split the ship in half. Glenn was recaptured by another Japanese convoy and sent to a Japanese prison camp. He weighed 85 pounds at the end of war and recuperated at Madigan Medical Center, He worked for ASARCO and enlisted in inactive Enlisted Duty. He was recalled to

duty at Fort Lewis, where he trained recruits in the Korean Conflict. He returned to ASARCO and eventually became a senior locomotive engineer. He also owned a radio and television repair shop and served as the authorized Sylvania repairman.

Glenn Oliver loved the outdoors, and spending time with his family. He camped, hunted, fished, did water and snow skiing, ice hockey, ice skating and boating.

After he retired he belonged to several genealogy societies, Disabled American Veterans, Military Order of the Purple Heart, American Ex-POWs, and the ADBC. He belonged to the Bethlehem Lutheran Church for over sixty years. Although his wartime experience was important to him, his daughter Cindy Watasuki said his family was his biggest love.

He is survived by his wife Esther; two daughters, Cynthia Wakatsuki and Elizabeth Cook (Richard Cook); grandchildren David Moffett (Monica), Sean Moffett, Michael S. Pedee (Michelle), Margaux Isaman (Cameron), Elizabeth Pedee, and Ryan Wakatsuki (Danielle), and great-grandchildren Lucas, Colin, Carson and Archer. March and a POW in Japan during WWII. Jim served with the U.S. Army Signal Corp (Sergeant Major) in the Philippines, surviving the Death March and POW experience in Japan to escape two weeks before war's end. MacArthur personally acknowledged Mr. O'Rorke at war's end at the Yokohama Grand Hotel in Japan. After recuperating at Fitzsimons Hospital he established himself in Red Feather Lakes and built a cabin lodge, as well as his own cabin which his family still uses frequently. He attended university at what is now UNC in Greeley where he met


his wife, Muriel O'Rorke (Tatelman), who predeceased him in 1991. While Panama visiting his in-laws in 1953, Jim was offered a position with the Canal Zone. This led to his lifelong career as a Foreign Service Officer (FSO1) with the U.S. State Department, with postings in Guatemala, Honduras and two voluntary tours of duty in Vietnam during that war. While serving, he received numerous commendations from various Presidents and high ranking State Department officials. He was also a 32nd Degree Member of the Masonic Temple. Jim was fluent in Spanish, Japanese and spoke Vietnamese and Mandarin. He stayed on top of current events and read the New York Times, giving him material for debate, discussion and many laughs with his friends. In November, he was able to meet President Obama during his campaign stop in Fort Collins. While in his 70s he decided to add a basement to his cabin in Red Feather Lakes. He used a pickaxe to break up rock, and shovels and wheelbarrows to move debris. While others chuckled, he continued on; the arduous work sustained him, and he outlived the skeptics. Jim leaves behind his children: Susan O'Rorke of Fort Collins, Robin O'Rorke of Fort Collins and Scottsdale, AZ and Regan O'Rorke currently living in Nicaragua. Susan's daughters Taryn and Teagan Sebba, will remember him fondly. They visited him most every day and became almost permanent fixtures at Rigden Farm. His other grandchildren include Kendall, Morgan and Riley who flew into town to honor their grandfather. His extended family in Ecuador led by Tomas O'Rorke-Araujo will also miss him. Jim will be remembered as a stubborn debater with a kind heart and passionate feelings for human dignity and the underprivileged. Jim contributed to many charities promoting the causes of equal rights, women's issues, racial and religious acceptance and other public causes. One of his favorite sayings was "Que sera, sera." -Whatever will be, will be.

## **Herbert Edward Pepper**

Master Sergeant Herbert Edward Pepper, 93, died early October 2, 2012 at the VA Hospital in Lake City, Florida after an extended illness. He was the son of the late Jesse Lee and Maggie Lula Veal Pepper. He had made

He was also a survivor of the Bataan Death March in April 1942. He retired from the VA hospital after 29 years. Herbert enjoyed going to the mountains, fishing, riding his bike, gardening and flowers. He is survived by his wife of sixty-five years Pauline Pepper, Lake City, FL, three sons Thomas Pepper (Renee) Panama City, FL, Herbert Pepper (Sherry) Lake City, FL, Michael Pepper (Kim) Live Oak, FL, two daughters Carol Giebeig, Lake City, FL, and Patricia Stapleton (Keith) Jacksonville, FL, one sister Roseman Ellison, Las Vegas, Nevada. Twelve grandchildren and sixteen great-grandchildren and one great-great-grandchild also survive. In 1949, Bruno started college and with the help of the GI bill he earned a BS degree from the Iowa State University in Ames, Phi Beta Kappa after just 2 and a half years. In 1952 he worked as a vocational agriculture and industrial arts instructor at Marion High School. Next he earned his Master's Degree in 1952 from the University of Colorado at Boulder. He returned to Marion teaching Physics, Chemistry, Qualitative Analysis, Biology and Math. Bruno treasured letters from students thanking him for how they positively affected their lives. After retirement he joined his wife Fran in her antique business working in that for 15 years. He became interested in competitive duplicate Bridge and played in many tournaments. He earned the most coveted Life Master ranking for competitive play. The title fit him in life as well as the game of bridge. David (Frieda) Wray of Fallbrook, CA and his daughter, Jan (Perry) Walton of Marion; five grandchildren, Alisa and Tapiana Wray, Gina and Shawn Holman, and Randy Walton; four great grandchildren; nephew, Carl (Maribelle) Lund; and niece, Carol (David) Pitts.
